CHANGES TO PRESIDENT:

- Due to personal commitments, Graham Osterfield will step aside as club president and board member, for the remainder of the 2023-2024 Rotary year.
- It was suggested that the President position be by name only (i.e. a 'nominal president') and the president's jobs be shared by other club members. **This was agreed by all present.** Lester Drew (our Assistant District Governor) said this was acceptable by District.
- We will need to notify My Rotary and Maggie (for DG) Kuok. For change of name.
- Di Scotte to become the club's 'nominal' president for the remainder of this Rotary year.
- All current board members will continue with their current roles.
- We will need to have a new 'Executive secretary' for the club, to ensure 2 club members are able to make changes to 'MyRotary' etc, if necessary. It was decided to firstly approach Nick Curry. Neville Blomeley could take on the role if Nick was unable to do so.
- The club Bulletin was discussed. Gerry Gebert has kindly offered to write the 'President's Report' for the club bulletin each month. It was finally decided to **CHANGE TO HAVING ONE CLUB BULLETIN PER MONTH.** Notify Nick and all members. It was suggested that the bulletin could be sent to all members **prior to the first Wednesday in the month**, so all members have an overview for the upcoming month prior to attending our first meeting of the month. Neville will continue to let Nick know who guest speakers will be. Gerry will notify all about the plan.
- Di will make the necessary changes to MyRotary about positions and also notify all members of change.
- President jobs to be allocated as they arise.
- Graham will continue his role with BeefBank.

- President elect was discussed. Quadocracy again? Or 2? Further discussion to come. (President Elect training in April – 20 and 21st. PE will need to attend.)
- Lester suggested we need to put together a **strategic plan** to help with consistency for a split presidency. The club will proceed with this.
- Discussed moving our club trailer and other Rotary gear from Graham's property. **Craig will be able to relocate the trailer at his workplace.**
- Graham's shed – to be cleared. By end of March – prior to Easter. **Working Bee at Graham's in March. 16th or 17th March. Craig will be able to store gear at his workplace.**

Lester – Strategic Plan and PETS training and Assembly. (One weekend.) (Craig will be attending.)

- Recently requested Report to District. Craig has done and Di will submit to Lester.
- Club technology – Lester suggested we could pay to get someone to do the updating on social media, as we have done previously. John may have someone who can do that. He will get back to the club.

- There was discussion about possibly approaching Ada as to whether they might be interested in a corporate membership of the club.
- Craig:** Net 6 month fundraising efforts – about **\$13,000. 46,700 meal portions** supplied to BeefBank worth \$93,400. Bim Struss (BB board) has done fantastic work. \$20K from RNA fundraising.
- BeefBank:** Beaudesert abattoir has closed. Andrew has found somewhere else to use.
- John – will follow up with Stoddard's.
- Lester – membership – It was suggested we could consider having a combined local clubs meeting. Ask those already doing voluntary work in the community and ask how Rotary can help them?
- Bob raised the issue of the expense of paying dues to be a full member of a Rotary club, and how this can be a big disincentive for prospective members. Discussed. Lester mentioned that Rotary allow up to 10% of funds raised to subsidise club expenses.
- Di** – RJCA – Di will approach local schools to start ASAP. Neville and Di agreed to try to approach Middle Park SS again to gauge their interest in an EarlyAct club for 2024.
